To ensure that the trainee is able to identify a potential for fall from heights hazard and to implement risk control measures which will minimise the danger of the worker falling

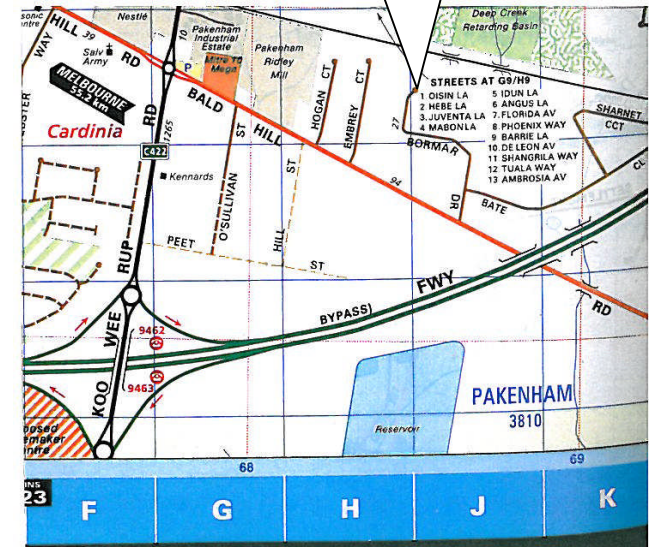
